






The AKRIPT platform will adopt a phased approach, prioritizing the extant industry in its initial phase and progressing towards diversification across multiple sectors in subsequent steps.





Release Schedule





AKRIPT will be unlocked in a predetermined schedule which lasts for 66 months from the public sale. The initial circulating supply is set to 90,000,000 AKT - 18% of the total supply. The total supply is 500,000,000 AKT

Incentives for Seed Investors



DISCOUNT

Seed investors can acquire AKRIPT at 50% discount (1GBP = 2 AKT)

BURN

10% of the token will be burned, minimizing supply, thus creating appreciation of the token price. Further to this, 1% of the transaction fees, received, will also be burned on every transaction

LIQUIDITY POOL

15% of the supply of tokens will be kept to support the liquidity pool, keeping the token price stable

FUNDS LOCKED

Founders will lock 20% of their tokens in a reputable Crypto Exchange for at least one year.

LOCK PERIOD

Only 20% of the private sale tokens will be unlocked during the first year of the AKRIPT public sale. The rest of the private sale tokens will be unlocked quarterly over the next 2 years. `this process will be controlled with smart contracts.

BUY BACK FUNDS

A smart contract will be created, where Seed Investors will have the option to sell their tokens by the end of the second year, with return of 100%.

STAKING

At the end of the first year, rewards are distributed fairly across token holders, on a quarterly basis, thus the token holders will benefit from price appreciation plus dividents.


CONTROLLED PUBLIC SPACE

Only 30% of the supply will be available to the public sale.

Transaction Tax



AKRIPT token (AKT) is an ERC20 token that has a 10% tax on every transaction. This tax is automatically distributed using a Smart Contract.



HOLDERS REWARDS.

Number one, it will give all existing holders dividends for simply holding the token. This causes the users to hold AKRIPT, for more extended periods.

BURN.

It automatically buys back and burns it, constantly shrinking supply and increasing your AKRIPT value with time. In this way, the total supply of the token lowered, making AKRIPT a deflationary token. The supply and demand theory states that the less there is of something, the more valuable it becomes.

Those who decide to hold their AKRIPT are rewarded as opposed to those who sell, so this mechanism encourages holders and discourages pump and dump traders. Holders are incentivized to hold their tokens because their holding will increase over time. And even if AKRIPT investors take no action, they still collect additional AKRIPT just by holding them.

Investors' Protection



LP LOCKED

The Liquidity Pool is locked, which means it can't be rug-pulled, thereby protecting investors

AUTO LP GENERATED

The auto Liquidity Pool help create a price floor for the token and also helps make the price more stable

BOT KILLER SMART CODE

Our bot killer code helps protect against trading bots that try to manipulate crypto prices

MULTI SIGNATURE WALLET

To provide extra security, a minimum of 3 signatures are required to unlock the Seed Investors Wallet



ANTI-WHALE MECHANISM

Number one, it will give all existing holders dividends for simply holding the token. This causes the users to hold AKRIPT, for more extended periods. In the cryptocurrency world, an anti-whale mechanism is a functional system that checks or counters the activities of the crypto whale(s) who use their immense wealth to manipulate the price of a cryptocurrency, this may include heavy volume selling of cryptocurrency to create a panic or run in the market. Retail investors bear the brunt of panic selling when faced with an unverifiable reason for a decrease in the price level. Retail investors incorrectly assume there is negative news that they simply don't have access to yet. Retail investors incorrectly assume whale(s) have some special knowledge and are selling quickly before the news becomes public.

To combat the problem, we've created "whale protection." Basically, if a large account holder wants to make a big sale, he'll have to deal with additional fees. This incentivizes him to either not sell or make sales across a larger time frame. well, those extra seller fees go into the Holder's Reward System. This means that if a whale wants to make a sale, he has to pay the community extra tokens for it to go through. For users, this puts more tokens in their wallets and helps keep the price of the token stable.

Transactions (sell/buy and wallet transfer) that trade more than 0.1% of the total supply will be rejected. This will protect price movement as well.

The Road to ICO



A state-of-the-art website is under development that will provide a strong impression to the target audience. The website will cover the details of the ICO project.

A digital marketing campaign will be prepared, using a specialist adviser.



Bounty campaigns will be launched, and Airdrop platforms will be used to execute the campaigns. A number of Airdrop tokens will be given to different users and influencers all over the world to incentivize them to promote token.





Form partnerships with numerous marketing/crypto influencers.



Paid promotions, advertising and sponsoring key events that attract target audience.







An advertising agency will be hired to prepare press releases etc. to promote the token to target audience.



One or two popular Exchange Platforms will be used to market the Token all over the world.



Five million of AKRIPT will be given to Retailers and Suppliers as Loyalty Points. The Tokeb supply will be gradually increasing in the system (more users) but because they will be keeping it in their wallets, price will be going up.



Use social media to reach the cryptocurrency community and utilizing apps such as WhatsApp and Telegram, to keep the AKRIPT community updated.
